The Mossad Agent

In 2014, I got employed at SCGH in Perth, Western Australia.

At work, I had many inter-actions with a Mossad agent I will call Katerina (she told me her name several times, but I didn't get it).

Katerina was definitely a Mossad Agent – Not Sayanim.

She was employed at SCGH a few months after I was hired.

She claimed to be an immigrant from an Eastern European country.

She was smooth as silk.

She moved around like a ghost.

I would start talking to a fellow worker and within a few seconds, Katerina would appear from nowhere, and slyly join the conversation.

Sometime in 2015, as I was sitting at the dining area at work, reading something on my phone, it suddenly went out of control, playing strange sounds at maximum volume.

I was quite startled and tried lowering the volume using the side button, but nothing happened.

The loud noise continued.

I was quite embarrassed, though luckily, only a few people were present.

I tried switching it off - nothing happened.

No button on the phone was working, while the very loud strange noises continued.

Finally, I managed to open the back case and removed the battery (It was an older Android phone with a removable battery).

That is when it went off.

I wondered how that had happened.

I decided to not to reconnect the battery until I went home after work.

The next day, I went to a smaller staff room during my break.

No other person was present.

A few minutes later, Katerina walked in, greeted me and sat opposite me across the table.

I answered her greetings politely, as I always did when a Mossad agent or Sayanim greeted me.

I went back to my phone, while she also appeared to be fiddling with hers.

She kept craning her neck, trying to see what exactly I was doing on my phone.

In my estimation, she appeared a bit unsettled, like someone waiting for something very important to happen.

I assumed that what had happened the day before was just a dry run.

On this day, they were most likely prepared to take control of my phone again, and either broadcast something that would greatly embarrass me, or create panic in the whole facility.

They probably hoped to accomplish that within the several seconds it would take me to react and remove the battery.

I knew such a tactic would most likely not work - Because I had decided to only be using my phone with internet off while at work.

i.e. To only use apps that didn't require internet to work.

And if that didn't work, I would then have removed the battery – but after great embarrassment/humiliation.

From Katerina's mannerisms, it seemed to me that she believed my internet must have been on, seeing me busy using apps on my phone.

Despite my unfortunate situation, the fact that Katerina was sitting opposite me waiting for something to happen, and knowing that despite their limitless resources they were unable to make it happen, I thought it to be quite amusing.

Eventually, Katerina realised I was suspicious of her, and mysteriously disappeared from work - never to return.

My Encounters with Mossad Moles

Between 2002-2010, I encountered Mossad impostors many times, but I never thought they were moles, since I had never heard or read about such a thing.

I always dismissed these Mossad moles' behaviour as weird characters, and forgot about them.

Men and women seeking desperately to be close to you, yet they cannot give any reasonable explanation why they want you to be their friend/associate.

Extremely bizarre.

There was one interaction I had with a Mossad mole around 2007/8 (though, of course I didn't know he was one).

His behaviour, or mien, and the way he was speaking to me, made me ask him directly: "Who are you?"

I wasn't suspicious of him.

In fact, I expected him to explain who he was, in a way that made sense...

On Twitter/X, I use my real name and phone number on my account @alloodsmobile.

Since 2020, I have publicly named more than 50 Mossad moles and Sayanim.

None has ever sued me for alleged libel, or demanded a retraction.

On 19 November 2023, I tweeted about the person I considered to be the most prominent Mossad Sayanim in Australia, Dr David D.J. Russell-Weisz.

He was then the Director-General of WA Health.

On 27 March 2024, Dr Russell-Weisz resigned from public service.

Mossad probably calculates that it would be more advantageous for them, if the story about their moles and Sayanim infiltrating public institutions in other countries 'went away quietly', for lack of 'corroboration' - Since no 'trusted' media has been brave enough to report about it.

If the matter went to court, then that secret would be known worldwide.

They would never take that risk...
